

## Project PEACE Part 2: Anxiety Disorders

### ACTIVITY DESCRIPTION

This course provides a comprehensive exploration of anxiety disorders as outlined in the Diagnostic and Statistical Manual of Mental Disorders, 5th Edition (DSM-5TR). In the first module, you will examine a range of anxiety disorders, including generalized anxiety disorder, separation anxiety disorder, selective mutism, and specific phobia. The second module will build upon this foundation, offering an in-depth review of additional anxiety-related disorders, such as social anxiety disorder, panic disorder, agoraphobia, and others. By the end of this course, you will gain a thorough understanding of numerous anxiety disorders, their characteristics, and diagnostic criteria.

### TARGET AUDIENCE
