

Project PEACE Part 2: Mood Disorders

ACTIVITY DESCRIPTION

This course offers a comprehensive overview of mood disorders, with a focus on both their clinical features and management strategies. In the first module, you will explore the symptoms and diagnostic criteria of various mood disorders, including major depressive disorder, persistent depressive disorder, premenstrual dysphoric disorder, bipolar disorder types one and two, cyclothymia, and mood disorders associated with substances or other medical conditions. The second module will build upon this foundational knowledge, focusing on effective management strategies for mood disorders. You will learn about both pharmacological and non-pharmacological treatments and interventions, gaining a thorough understanding of how to best support individuals with mood disorders.
